This Contract binds both Aalto Executive Education Academy Pte Ltd ("Aalto EE") and the Student once both parties sign this Contract.

1. COURSE INFORMATION AND FEES

- 1.1 Aalto EE will deliver the Course as set out in Schedule A to the Student, towards conferment of the stated qualification upon successful Course completion.
- 1.2 Aalto EE confirms that the Course has been permitted by the Council for Private Education (CPE) and no amendments have been made to the Course as set out in Schedule A, unless otherwise permitted by CPE.
- 1.3 The Course Fees payable are set out in Schedule B.
- 1.4 Aalto EE considers payment made 14 days after the scheduled due date(s) in Schedule B as late. Aalto EE will explain to the Student its policy for late payment of Course Fees, including any late payment fee charged in Schedule C (if applicable) and any impact on Course/module completion (if applicable).
- 1.5 The Student has received the student handbook for the course and acknowledges other course-specific rules and guidelines defined therewithin.

2. REFUND POLICY

2.1 Refund for Withdrawal Due to Non-Delivery of Course:

Aalto EE will notify the Student within three (3) working days upon knowledge of any of the following:

- (i) It does not commence the Course on the Course Commencement Date;
- (ii) It terminates the Course before the Course Commencement Date;

* Delete as appropriate by striking through.

Where non-applicable, put "N.A.". Leave no fields blank.

State all dates in the format of DD/MM/YYYY.

- (iii) It does not complete the Course by the Course Completion Date;
- (iv) It terminates the Course before the Course Completion Date; or
- (v) It has not ensured that the Student meets the course entry or matriculation requirement as set by the organisation stated in Schedule A within any stipulated timeline set by CPE.

The Student should be informed in writing of alternative study arrangements (if any), and also be entitled to a refund of the entire Course Fees and Miscellaneous Fees already paid should the Student decide to withdraw, within seven (7) working days of the above notice.

2.2 Refund for Withdrawal Due to Other Reasons:

If the Student withdraws from the Course for any reason other than those stated in Clause 2.1, the Course Fees already paid to Aalto EE are non-refundable.

2.3 Refund During Cooling-Off Period:

The PEI will provide the Student with a cooling-off period of seven (7) working days after the date that the Contract has been signed by both parties.

The Student will be refunded 100% of the fees already paid to Aalto EE if the Student submits a written notice of withdrawal to the PEI within the cooling-off period, regardless of whether the Student has started the course or not.

3. ADDITIONAL INFORMATION

- 3.1** The laws of Singapore will apply to how this Contract will be read and to the rights the parties have under this Contract.
- 3.2** If any part of this Contract is not valid for any reason under the law of Singapore, this will not affect any other part of this Contract.
- 3.3** If the Student and Aalto EE cannot settle a dispute using the way arranged by Aalto EE, the Student and Aalto EE may refer the dispute to the CPE Mediation-Arbitration Scheme (www.cpe.gov.sg).
- 3.4** Aalto EE may collect, use, or disclose the Student's personal data collected in this form and at the point of application for the following purposes:
 - (i) for providing services to you and to fulfilling your requests and to communicating with you with regards to MBA for Executives program, for example in order to provide information about our services related to this program;
 - (ii) in order to improve and develop our business and services;
 - (iii) to customize our services to you;
 - (iv) for marketing research purposes or to inform you about our new services or products or promotions we may offer;
 - (v) for collecting data for statistical purposes;
 - (vi) for statistical purposes relating to international ranking surveys and international accreditations (without connecting the individual person to the provided information)
 - (vii) for compliance with mandatory legal requirement(s) or in connection with law enforcement or other legal proceedings or when needed in order to defend our legitimate interests.
- 3.6** Any agreement other than this Contract is invalid if it is administered without the written permission of Aalto EE. If there is any other agreement between Aalto EE and the Student that is different from the terms in this Contract, then the terms in this Contract will apply.

- 3.7** If the Student or Aalto EE does not exercise or delay exercising any right granted by this Contract, the Student and Aalto EE will still be able to exercise the same type of right under this Contract during the rest of the time the Contract continues.
- 3.8** If this Contract is also signed or translated in any language other than English and there is a difference from the English language copy of this Contract, the English language copy will apply.
